Purpose of Staff Report

The purpose of this report is to provide an update on the activities that Severn Sound Source Protection Authority staff and SSEA Risk Management staff have completed during the fourth quarter of 2018.

Background

Under the Clean Water Act, 2006 the SSEA is one of the Source Protection Authorities within the South Georgian Bay Lake Simcoe Source Protection Region (SGBLS SPR) and work with our member municipalities as well as the District Municipality of Muskoka to implement the Drinking Water Source Protection (DWSP) Program.

Historically staff of the SSEA has been delegated by 8 municipalities (District Municipality of Muskoka, Townships of Georgian Bay, Severn, Oro-Medonte, Tay, Tiny, and Towns of Midland and Penetanguishene) to preform risk management services on behalf of their municipality under Part IV of the *Clean Water Act*. To date that work has included verifying significant drinking water threats (SDWTs) via phone calls, surveys, and site visits and if a SDWT was found, staff have started the process of negotiating risk management plans for a few properties. Answering inquiries from the general public or municipal staff and commenting on development proposals is also a large part of what the risk management staff does.

Analysis:

During the fourth quarter of 2018 Source Protection Authority staff has been completing the following tasks:

- As a region submitted a Clean Water Act section 36 workplan to the Province through LSRCA
- Renewed Clean Water Act Part IV delegation agreement with the District Municipality of Muskoka, and in principle with the Town of Penetanguishene
- Participated in 1 regional meeting, 1 provincial teleconference, and 1 regional working group
- Facilitated 1 SS SPA meeting, and 1 Severn Sound Source Water Municipal Working Group meeting
- Supported Tiny Township in preparing their ROMA Ministers meeting request
- Coordinating meeting with the Minister of Environment, Conservation and Parks regarding Source Water Protection program/funding concerns (was set for January 2019, Ministers office cancelled mtg.)

Purpose of Staff Report

The purpose of this report is to provide an update on the key activities and accomplishments of the SSEA Invasive Species Program.

Background

Since the inception of the SSEA Invasive Species Program in 2017, the SSEA has worked effectively to reduce the ecological, economic and social impacts of invasive species, while fostering government partnerships and community relations. The Townships of Tay, Tiny, and Severn and the Town of Midland have supported the program since 2017, and the Township of Georgian Bay joined the program in the latter part of 2018.

The first two years of SSEA's Invasive Species Program have generated significant momentum in support of invasive species education, monitoring and management from local municipalities, community groups and residents. The SSEA frequently receives requests for invasive species management guidance, presentations, technical workshops and identification assistance from groups and individuals across the entire Severn Sound area.

Program Outcomes

Key accomplishments to date include:

- Monitoring- detection of 37 different invasive species (1,000+ observations) in Midland, Tay, Tiny, Severn and Georgian Bay including: phragmites, giant hogweed, emerald ash borer and dog strangling vine
- Management- engaged 167 volunteers who contributed 668 volunteer hours and approximately \$13,360 of in-kind value at 15 sites, removing over 4,500 kg of invasive plant material from municipal properties; supported multiple invasive species removal projects on private land
- Communication- reached approximately 1,600 people at 39 events; provided municipal training on invasive species identification; produced 13 invasive species news articles; led the 4th Municipal Invasive Species Working Group meeting; delivered technical workshops on invasive aquatic plant management and presented at multiple events including: the SSEA Open House, the Ontario Invasive Plant Council Conference, the Latornell Conservation Symposium, the Lafontaine Area Master Planning Committee and the Fisheries and Oceans Canada Training Convention
- Staffing- IS Community Outreach Liaison hired in partnership with the Ontario Federation
 of Anglers and Hunters *Invading Species Awareness Program*, for 8 weeks in summer;
 cost to SSEA was \$0.25 per hour for a total of \$69.00 for the duration of the contract
- SSEA value recognition/cost recovery- the SSEA IS program and Program Coordinator are recognized as leading experts and as such have delivered training to outside agencies, including Fisheries and Oceans Canada on a cost recovery basis.

Activities planned for 2019 include:

- Consultation with municipal members on, and finalization of, the Severn Sound Invasive Species Strategy
- · Removal of priority invasive species populations
- Expanded terrestrial and aquatic invasive species monitoring, within participating municipalities
- Survey of local nurseries, greenhouses and garden centres for potential sources of ornamental invasive species introductions
- Development of a SSEA Approved Native Species Planting List for Commercial, Industrial and Residential Applications
- Organization of additional Municipal Invasive Species Working Group Meetings

Funding Update

 Received \$39,500 in 2018 as municipal funding which returned an additional \$132,875 in municipal benefit (includes in-kind contributions and \$22,430.90 in grants from federal and provincial programs and foundations) SSEA Board approval for 3rd year of the Invasive Species Program and an increased budget of \$60,000

Analysis/Discussion

As the scope of the SSEA Invasive Species Program continues to expand within the Severn Sound watershed, the need for a coordinated approach to the monitoring and management of invasive species becomes ever more apparent. Provincial trends indicate that rates of invasive species introductions and resource requirements for eradication programs continue to rise. Cooperation between local governments, non-profit organizations, community groups and citizens alike will be essential for protecting the natural heritage of the Severn Sound watershed and the livelihood of its residents through a commitment to taking action against invasive species.

Severn Sound Environmental Association (SSEA), founded in 1997, is a partnership between federal, provincial, municipal and community partners. The SSEA provides continuing support to our partners as well as community organizations, to develop cost-effective environmental projects. The SSEA is committed to ensuring exceptional environmental quality and exemplary stewardship of the Severn Sound area through sound science, collaboration and partnerships.

The SSEA is committed to working with like-minded groups and associations to achieve results on issues such as invasive species. Accordingly, the SSEA supports in principle to the proposed Georgian Bay Forever (GBF) community project to reduce the impact of invasive Phragmites (*Phragmites australis ssp. australis*) on water quality. The proposed project is complementary to the SSEA's ongoing multi-species, multi-municipality Invasive Species Program, which is focused on mapping and reporting invasive species, education and outreach, and facilitating invasive species management on publically-owned properties. Much of the shoreline in the SSEA area is privately owned, and there are few resources available to assist private landowners with Phragmites removal. The GBF initiative addresses a need by providing assistance to private landowners with on-the-ground Phragmites management.

Without management, invasive Phragmites will spread and out-compete native plants, reduce habitat, impair the proper functioning of wetlands, and impede recreational access to Georgian Bay shorelines. GBF worked with private landowners in the Township of Tay with Phragmites management in 2018, removing over 21,000 pounds of Phragmites and educating more than 100 residents. Each Phragmites stand may take up to five years to eradicate, thus Phragmites management must be monitored and resourced on an ongoing basis. Funding for the GBF proposal would support and expand their Phragmites project.

If funding is approved for the GBF project the SSEA is prepared to provide in-kind support (approximate value of \$1,500 per year for three years) as our resources allow. This may include promoting the program to residents, assisting in the recruitment of volunteers, and participating in management efforts.

We look forward to working with Georgian Bay Forever to mitigate the impacts of invasive Phragmites in the SSEA area.

The Severn Sound Environmental Association (SSEA) appreciates the opportunity to comment on the proposed open-for-business tool under Bill 66 *Restoring Ontario's Competitiveness Act, 2018.*

The SSEA is committed to ensuring exceptional environmental quality and exemplary stewardship of the Severn Sound area through sound science, collaboration and partnerships. The SSEA is a Joint Service Board under the *Municipal Act*, working closely with eight lower tier municipalities and two upper tier municipalities in the Severn Sound area, as well as provincial and federal government, agencies and non-government organizations. The SSEA collects environmental data and provides expertise to member municipalities, works to keep water clean so it supports healthy terrestrial and aquatic ecosystems, as well as in identifying and documenting natural heritage features for several member municipalities for use in their Official Plan updates. The SSEA is the local Source Protection Authority in the area and has been delegated Part IV powers (enforcement of the act) under the *Clean Water Act* for all but one of our member municipalities.

The SSEA is proud of the work our municipalities do to ensure a thriving local economy while protecting and restoring water quality and natural heritage. It is the SSEAs understanding the proposed open-for-business (OFB) planning by-law would be used on a site specific basis to allow what would have otherwise been a non-permitted use based on various regulations (i.e. Provincial Policy Statement, Planning Act, Clean Water Act, and municipal specific Official Plans) to go ahead if various employment thresholds are

met. The SSEA offers the following comments on the proposed open-for-business tool under Bill 66 Restoring Ontario's Competitiveness Act, 2018.

Numerous established planning requirements and land use restrictions, plans, policies, regulations and legal requirements (e.g., Clean Water Act, Provincial Policy Statement (PPS), Growth Plan for the Greater Golden Horseshoe, municipal Official Plans, etc.) were established based on years of science and research. Municipalities who are not in Conservation Authority regulated areas need support to uphold environmental standards such as Great Lakes Remedial Action Plan commitments and Clean Water Act. The Province should ensure that the OFB tool/by-law does not undermine the very things that a healthy economy and health community are based on, clean water, natural heritage features which are often critical green/natural infrastructure (ie. Wetlands), farmland and human health

The Province is commended on looking for efficiencies for Ontario businesses, municipalities and residents. The Ministry is encouraged to consider the potential impacts of site or municipal specific by-laws on groundwater and natural heritage systems and corridors that extend beyond site and municipal boundaries. Natural heritage systems often double as natural green infrastructure and clean water is critical to the health of all Ontario's, both underpin the health of our local and Provincial economy.

The SSEA is proud of the work our municipalities do to ensure a thriving local economy while protecting and restoring water quality and natural heritage. We look forward to working with our municipalities and the Province of Ontario to ensure clean water and natural heritage are protected as the underpinning of our healthy economy.
