
Background

The external funding sources, including other levels of Government, are unpredictable and short term.

In the 2018 – 2023 SSEA Strategic Plan, the need to "identify and implement opportunities to ensure funding for SSEA is secure and sustainable over the long-term" was identified as a priority action. One option would be to establish a registered Foundation for Severn Sound.



Analysis/Discussion
