A total of 219 posts were made on SSEA Instagram, Facebook and Twitter accounts on a variety of topics and SSEA programs this quarter to audiences of 535, 391, and 427 followers respectively. A total of 3 new videos related to SSEA programs, results, or recording of webinars and meetings were posted on the SSEA YouTube channel with a total of 316 views and 42 subscribers. SSEA participated in Earth Week and National Pollinator Awareness Week campaigns by posting across all social media.

#### **Events/Meetings/Conferences**

SSEA co-hosted the *Communities in Watershed Action* Mini-Summit with Ausable Bayfield Conservation Authority, drawing approx. 90 attendees from across the watershed and beyond. The event included guest speakers, displays from SSEA and partner agencies, and networking opportunities. Two staff members attended and presented research at the Joint Aquatic Sciences Meeting on invasive species, and physical limnology in Severn Sound. Team SSEA participated in

and events throughout the quarter.

SSEA responded to 48 inquiries from municipal partners, members of the public, and contractors.

## **Tree Planting**

Planting and Distribution

Community Tree Planting: SSEA coordinated planting of 1,455 seedlings of nine species at two sites (in Oro-Medonte and Tiny) in April/May by several Scouts Canada groups, SSEA staff and Board members, volunteers and landowners. Seedling costs (\$1,705) are covered through a MOU with the County of Simcoe Forestry department.

Tree Seedling Distribution: 8,740 seedlings were planted by 228 participants across all eight SSEA municipalities. THANK YOU to municipal staff and councils that promoted and supported the program.

#### Fish and Wildlife Habitat/Natural Heritage

Invasive Species, Species at Risk, Wetlands, Wildlife and Habitat Stewardship

#### **Invasive Species**

2021 Municipal Invasive Species Reports were distributed to each member municipality. Participated in and/or hosted 6 invasive species management events. Installed artificial substrates in Orr Lake to detect the presence of invasive mussels. Submitted Phragmites DNA samples to the Invasive Species Center for identification. Completed aquatic plant surveys in Sturgeon Bay with transport provided by Georgian Bay Forever.

Completed Giant Hogweed monitoring on the Uhthoff Trail with the Township of Severn. Continue to deliver technical and field monitoring support on the Wye Marsh Invasive Species Management and technical support on the Farlain Lake Eurasian Water-

milfoil Management projects.

#### Species At Risk

Initiated 2022 field work for Matchedash Bay Turtle Monitoring Project, as part of a partnership with Georgian Bay Forever. THANK YOU to Township of Severn and County of Simcoe for installing turtle crossing signs in the project area.

#### **Land Use Planning**

**Input and Review** 

#### Plan and Policy Input

SSEA contributed comments on 22 applications, reports, and Environmental Impact Studies, an increase of 22% compared to the number of projects reviewed in Q2 of 2021. Staff also provided comments on the Township of Oro-Medonte draft Official Plan.

#### **Drinking Water Source Protection**

Source Protection Authority and Risk Management Services

#### Source Protection Authority Services

Staff attended 7 regional or provincial meetings on various topics such as communications, assessment report update requirements, Source Protection Committee meetings, and risk management topics specific to the Drinking Water Source Protection Program. Staff continues to support municipalities in meeting their requirements with potential changes to various water systems in the municipalities of Oro-Medonte, Tiny, and Midland. Completed an update to impervious surface mapping around municipal drinking water systems to support potential policy changes around salt and snow storage.

#### Risk Management Services

This quarter, staff commented on 12 development applications, answered 10 inquiries, and attended 1 pre-consultation meeting.

#### **Monitoring Programs**

Field/data collection: Open Water, Inland Lakes, Intakes, PWQMN/Tributaries, Stream Invertebrates, Stream Temperature, PGMN, Climate, and Citizen Science

#### Lake Sampling (Open Water, Inland Lakes, Intakes)

A total of 6 Tay intake sampling events have taken place, 3 sampling events on Severn Sound open waters, including an additional run on North Bay, and 5 inland lake sampling events each on Farlain and Little Lakes. A big THANK YOU to Georgian Bay Forever for taking the crew out for the first run of the season. Sampling included collecting water chemistry and field data such as pH, turbidity, conductivity, and temperature. Water quality results are used to assess lake conditions and guide management decisions.

# <u>Tributaries (Provincial Water Quality Monitoring Network (PWQMN), Stream Invertebrates, Temperature)</u>

The monitoring team completed 3 PWQMN sampling runs at 14 sites throughout the watershed, collecting chemistry

and corresponding field data such as temperature, dissolved oxygen, conductivity and turbidity. Identified 2,606 stream invertebrates in samples from 8 long-term stations in the Coldwater River, Lafontaine Creek and Hogg Creek watersheds to assess tributary health.

#### Groundwater (Provincial Ground Monitoring Network)

Downloaded level and baro loggers (hourly data) and completed spring maintenance checks at 8 well locations. The data is used to monitor long-term trends and assess if climate change is impacting groundwater.

#### Climate

Four rain gauges and one air temperature logger have been installed in the Town of Penetanguishene, and townships of Oro-Medonte, Tay and Tiny. Staff has begun installing temperature loggers at stream sites throughout the watershed to monitor in-stream temperature during the summer months. An intensive stream temperature study has also begun that will focus on areas in the Coldwater River subwatershed. This study will help to update drainage mapping, determine thermal classification of all stream reaches, and help to better understand where to focus future monitoring and restoration efforts.

The Midland and Lafontaine weather stations were checked and data was downloaded monthly. Near real-time data can be viewed on the <u>SSEA website</u>.

<u>Citizen Science (Shore Watch, Stream Watch, Ice Spotters, Invasive Species Spotters, Water</u> Level Watch)

The <u>2021 Citizen Science Data Report</u> is complete and can be found online.

Stream Watch and Shore Watch programs are up and running for the 2022 season. We have 22 volunteers monitoring 20 sites. All Citizen Science equipment kits have been delivered to volunteers, who are now submitting data. This includes volunteers participating in the Invasive Species Spotters program monitoring for aquatic invasive species.

Observations for the Water Level Watch program on Farlain Lake are being submitted. So far in 2022 we have received 27 observations from 2 volunteers on Farlain Lake.

## Sustainable Severn Sound Special Project

Climate Change Action Plans, Partners for Climate Change Protection (PCP) Program

Worked with a local video producer to create a video on Climate Change in our Backyards.

#### Partners for Climate Protection

SSEA continues to support our municipal members of the PCP program, facilitating actions under municipal climate action plans where possible.

#### Bee City Initiative & Projects for Pollinators

SSEA staff continues to support Severn Sound watershed Bee City members (Midland, Tiny, Severn, Georgian Bay). We are continuing to work with the Town of Midland on their No-Mow Zone Project. Staff also provided content for their Bee City webpage. To celebrate National Pollinator Week, SSEA participated in the Midland Bee City Mural reveal. SSEA and Midland staff have been planning the restoration of an additional site at Little Lake Park. The site will undergo invasive species management and replacement with native species.



Staff delivered 2 Earth Week webinars to Township of Tiny residents on Bee Cities and

Pollinators and participated in the Bee City Plaque reveal (press release: <u>Township of Tiny Unveils Bee City Plaque</u>).

Received a grant from TD Friends of Environment Foundation for SSEA's Projects for Pollinators initiative. Staff has been working on producing a pollinator garden kit with seed packs, no-mow lawn flags and a pollinator garden handbook and species guide. Created a recommended native species list. Pollinator-attracting native plants will be planted in partnership with Bee City members, coinciding with invasive species management efforts. Handed out seed packs at events across the watershed. Ran a social media campaign for Pollinator Awareness Week, and created a section on SSEA's website on Pollinators.

#### Depave Paradise Program

Worked with the Township of Georgian Bay to complete their Depave Project. Volunteers removed ~100m² of asphalt and planted ~100m² of pollinator gardens. Plantings included 33 species of native trees, shrubs, grasses and wildflowers with a total of 346 plants. A total of 38 volunteers participated, including 16 grade 4-8 students from Honey Harbour Public School.

- Regional Climate Change Exchange meeting
- ICECAP Climate Adaptation workshop
- Regional Depave Coordinator meeting
- Midland Bee City meeting

# **Data Analysis and Reporting**

Statistics, Data Management & Analysis, Reporting, and GIS/Mapping

#### Statistics/Data Management & Analysis

Routine, year-round data management consisting of PWQMN, Georgian Bay water levels and regional climate data, and open water/inland lake water chemistry, zooplankton and algae data processing continues as normal. Additional analyses were completed for open water temperature profiles, relating water level fluctuation to explain patterns in temperature and algae growth.

#### Reporting and Educational Content

SSEA completed 5 conditions updates for both Farlain and Little Lakes, which can be viewed <u>online</u>. Posters detailing results for PWQMN, PGMN, Climate Monitoring, Stream Temperature Monitoring, Open Water and Inland Lake Monitoring were updated for the mini-summit.

#### **Partnerships**

New/Updated NGO partners and MOU's, Academia

SSEA is always working with new municipal and NGO/external partners to deliver effective environmental stewardship, including membership with GBB's ICECAP and the SMDHU's Climate Change Exchange Committee and Climate Change Charter Working Group. Investigated the Simcoe Loop Trail to identify educational signage sites in partnership with the County of Simcoe.

The ED continues to be a Director on the Huronia Community Foundation Board and the associated Vital Signs report working group as well as the Healthy Great Lakes Advisory Committee & Water Team (CELA lead).

Team SSEA hosted a virtual "meet and greet" with the staff in Barrie Ministry of Environment, Conservation and Parks (MECP) and the Ontario Clean Water Agency staff working in Tay.

#### **RECOMMENDATION:**

RESOLVED THAT: Staff Report No. 15-22-SSEA regarding the 2021 Draft Financials and Audit be received as information.

#### **Purpose of Staff Report**

The purpose of this report is to provide the Board with up-to-date 2021 draft financials. Further to our relationship with our Treasurer municipality, as year-end information is processed, the 2021 financials are updated accordingly and presented to the Board leading up to the annual audit.

#### **Background and Analysis**

Please be advised that the 2021 Draft Financial Report reflects that SSEA is in a net revenue position as expected. This is mainly due to a reduced amount of core spending; core expenses are at 85% of budget. Payroll expenses are under budget due to unfilled staff vacancies. SSEA also has savings in travel, legal costs, supplies/materials and training.

Core project and cost recovery revenues are underbudget, and are mostly offset by external funding for staff that was not included in the 2021 budget: Canada Summer Jobs, Biotalent Canada, ECO Canada and Community Development Corporation (CDC).

In terms of Projects, note that as previously indicated, the funding for the SSS Project in 2021 is short \$6,266 due to only six confirmed municipal partners where the budget included seven. This shortfall is more than offset by the 2021 surplus so no further action is required.

In addition, the DWSP Program reflects zero as was the case throughout 2021. This is due to the provincial funding agreement being signed after the 2021 budget was set. At the special meeting of the Board held on February 4, 2022, it was decided that the municipal DWSP funding

for 2021 would be transferred to the SSEA reserve. This is reflected in the attached 2021 draft financials.

SSEA also received additional funding in 2021 that was not included in the 2021 budget: Farlain Lake and Wye Marsh projects, Great Lakes Local Action provincial funding (Healthy Soils=Healthy Watershed Project), Citizen Science Project, Matchedash Bay Turtle Project (Species at Risk) and Depave Paradise Project.

Other adjustments may be determined by the audit firm during the annual financial audit.

#### Conclusion

The SSEA team was extremely diligent, spending frugally and securing external revenue sources. SSEA will finalize 2021 in a surplus position.

As of July 12<sup>th</sup>, SSEA has no information on the timing of the 2021 financial audit.

SUBJECT: 2023 Draft Budget

Strategic Plan Goal 4: An Exceptional Organization

#### **RECOMMENDATION:**

RESOLVED THAT: Staff Report No. 17-22-SSEA regarding the 2023 Draft Budget be received; and

FURTHER THAT: The Board approves the Executive Committee's recommendation to approve an overall 2023 increase of \$36,300 over the 2022 Final Budget for the municipal contributions portion of the Core 2023 Budget; and

FURTHER THAT: The Board approves the Executive Committee's recommendation to approve the use of reserves to fund payroll increases resulting from the current Pay Equity and Compensation Review in order to reduce the impact on municipal partners.

#### Purpose of Staff Report

The purpose of this report is to obtain Board approval for the Draft 2023 Budget as recommended by the Executive Committee of the Board which reflects the policy and service direction set out in SSEA's Strategic Plan, while meeting the support requirements of its municipal partners – recognizing the fiscal challenges posed by the COVID pandemic and current economic conditions to all agencies. As well, SSEA is seeking Board approval for the use of reserves to fund potential payroll increases resulting from the Pay Equity and Compensation Review for staff which is currently underway.

#### **Background and Analysis**

On July 18<sup>th</sup>, 2019, the SSEA Board of Directors approved both the 2020 Budget, and in principle the proposed five-year plan for 2020 to 2024.

The 2023 Budget approved in principle (in the original 5-year budget planning process) reflected a 2% increase. However, in 2022 the Board approved a 2022 Budget reduction of 2.1% from the 2022 approved in principle. The result of carrying over the 2.1% reduction into 2023 is that

the 2023 Budget *approved in principle* now reflects an increase of 4.1% in municipal core funding of \$36,300. Note, this is below current inflation rate for Ontario which is at 7.8% from May 2021 to May 2022 (Stats Can.).

In addition, SSEA now has a signed 2-year agreement for Provincial funding for Source Water until March 31<sup>st</sup>, 2024. This has provided some budget room which Staff recommends be added to the payroll section of the budget in order to continue to meet service expectations of municipal partners, and to address the issue of attracting and retaining expert staff, given the increasing workloads and extremely competitive job market. This will also allow the required flexibility to enable SSEA to participate in funding opportunities as they arise.

In terms of the current *Pay Equity and Compensation Review*, it is recommended that SSEA uses reserves to fund any increases that will result from this review in order to reduce the impact on municipal partners. The consultant has advised that this could be 5% to 10% increase on current wages which could result in additional costs to SSEA of \$50,000 to \$100,000. The Contingency Reserve and the Employee Benefits Reserve currently contain \$182,000 that are available for the purpose of reducing the impact of the increase. This review and potential costs will be completed later in the summer of 2022 (likely August or September) and will require a special meeting of the Board prior to the 3<sup>rd</sup> Quarter meeting.

Recognizing the budget constraints that all are facing, the SSEA provided various 2023 budget options for the Executive Committee's consideration at its June 13<sup>th</sup> meeting. 2023 will be a significant year for SSEA including the 20<sup>th</sup> Anniversary of SSEA Celebrations, strategic plan renewal, potential impact of the *Pay Equity and Compensation Review*, as well as, adapting to increasing inflation.

#### Conclusion

The approach to formulating the 2023 Budget is designed to ensure SSEA continues to provide the key services required by its municipal partners and watershed constituents, while meeting its own organizational requirements – with the goal of getting SSEA back into alignment with its Five-Year Plan, as well as, being compliant with the Pay Equity Act.

#### **RECOMMENDATION:**

RESOLVED THAT: Staff Report No. 18-22-SSEA regarding the SSEA Staffing Costs Update be received as information.

#### **Purpose of Staff Report**

The purpose of this report is to provide the Board updated information on SSEA staffing costs.

#### **Background**

SSEA currently pays Mandatory Employment Related Costs (MERCs), Ontario Municipal Employees' Retirement System (OMERS) contributions and employee group benefits premiums on behalf of employees. MERCs are costs that employers are required to pay based on federal or provincial/territorial laws. MERCs under the federal law include Employment Insurance (EI) and Canada Pension Plan (CPP). MERCs under provincial law include Employer Health Tax (EHT) and Workplace Safety and Insurance Board (WSIB) premiums.

#### **Analysis/Discussion**

#### EI:

Effective January 1<sup>st</sup>, 2023 EI premium rates will increase following a two-year freeze. However, increases can occur annually when maximum insurable earnings, that EI premiums are based on, increase. The maximum insurable earnings increase for 2022 is 7.1% over 2021. The EI rate and the maximum insurable earnings information for 2023 is not yet known.

#### CPP:

Starting in 2019, CPP has been gradually enhanced. This means both employers and employees make higher contributions which result in increases to the CPP retirement pension, post-retirement benefit, disability pension and survivor's pension for employees. The increase in contributions as a result of the enhancement is being phased in gradually. From 2019 to 2023, the contribution rate will gradually increase by one percentage point (from 4.95% to 5.95%) on applicable earnings.

#### EHT:

The rate for EHT has been the same for many years and no new information is available to indicate any changes in 2023. SSEA currently pays 1.95% of payroll.

#### WSIB:

SSEA pays the same rate of WSIB as our Treasurer municipality, the Township of Tay. The current rate is \$2.72 per \$100.00 of earnings. Any change in rate will not be known until notification is received from WSIB.

#### **OMERS Pension Plan:**

Effective January 1, 2023, OMERS is removing the current eligibility requirement for non-full-time employees to join the Plan so that all non-full-time employees, including those who are currently ineligible, may elect to join the Plan at any time after December 31, 2022. Enrolment in the Plan would take effect on the first day of the month after the employee's election is received and would remain in place as long as the member continues working for their current employer.

The 2022 contribution rate is 9% of earnings up to \$64,900 (2022 CPP earnings limit) and 14.6% on additional earnings. The 2023 contribution rate is not yet available.

OMERS indicates that additional details will be communicated around the administration of this change over the coming months, closer to the implementation date.

#### Employee group benefits

SSEA continues to be part of a multi-employer consortium plan consisting of municipalities and municipal organizations, developed by Mosey & Mosey and LAS for employee group benefits. The benefits are provided through Sun Life. The Plan allows SSEA to achieve reduced costs through volume discounts and reduced administrative costs. Any rate changes are a result of overall performance of the insurer's pool, demographics and claims (life and disability) and utilization (health and dental). SSEA's renewal is November 1st annually. The Board will recall that the previous renewal in November 2021 resulted in a 5.4% decrease in premiums. The insurer advised in May that they are currently projecting no change to SSEA rates in November, assuming the experience in the last quarter remains the same as the rest of the year.

#### **Financial Implications**

All employer payroll costs affect the SSEA budget. Efforts have been made to ensure that the payroll budget for 2023 includes funds to cover these costs as much as possible. This has been indicated in staff's report on the 2023 budget.

#### **Purpose of Staff Report**

The purpose of this report is to provide an update on the activities that Severn Sound Source Protection Authority and SSEA Risk Management staff has undertaken during the second quarter of 2022.

#### **Background**

Under the *Clean Water Act*, 2006 the SSEA is one of the Source Protection Authorities within the South Georgian Bay Lake Simcoe Source Protection Region (SGBLS SPR) and work with SSEA's member municipalities, as well as, the District Municipality of Muskoka to implement the Drinking Water Source Protection (DWSP) Program.

Historically staff of the SSEA has been delegated by 8 municipalities (District Municipality of Muskoka, Townships of Georgian Bay, Severn, Oro-Medonte, Tay, Tiny, and Towns of Midland and Penetanguishene) to preform risk management services on behalf of their municipality under Part IV of the *Clean Water Act*. To date that work has included verifying significant drinking water threats (SDWTs) via phone calls, surveys, and site visits and if a SDWT was found, the negotiation of risk management plans is underway. Answering inquiries from the general public or municipal staff and commenting on development proposals is also a large part of what the risk management staff does.

# Analysis/Discussion

Source Protection Authority (SPA) – During the second quarter of 2022 Source Protection Authority staff completed the following tasks:

- Signed the 2022-2024 funding agreement with Lake Simcoe Region Conservation Authority
- Continued to support municipalities in updating Assessment Reports for new or changing water systems in Oro-Medonte, Tiny, and Midland
- Attended 7 regional or provincial meetings on various topics such as communications, assessment report updates requirements, Source Protection Committee meetings, and risk management topics specific to the drinking water source protection program
- Completed an update to impervious surface mapping around municipal drinking water systems to support potential policy changes around salt and snow storage.
- Nicole Stott joined the DWSP program in Q2 as the Drinking Water Source Protection Assistant to aid the Risk Management Official/Inspector in carrying out DWSP program and SPA duties

Risk Management Services - During the second quarter of 2022 risk management staff has completed the following tasks:

- Commented on 12 development applications, answered 10 inquiries, and attended 1 preconsultation meeting
- Completed windshield surveys for most significant drinking water threat properties
- Started drafting 20 Risk Management Plans

# **Purpose of Staff Report**

The purpose of this report is to inform the Board of the current status of SSEA's lease with Newmarket Hydro regarding the administration office located at 489 Finlayson Street in Port McNicoll, ON.

#### **Background and Analysis**

On May 28<sup>th</sup>, 2018 the Severn Sound Environmental Association signed a 5-year lease with Newmarket-Tay Power Distribution Limited for the use of the 2000 square foot office currently utilized by SSEA. The rents outlined in the Agreement are:

The Lease started May 1, 2018 and expires April 30, 2023.

Section 3.2 of the Agreement states:

- "...the Tenant shall have the right to extend this Lease for one (I) further term of five (5) years (the "Extension Term"). Such extension shall be on the same terms and conditions as in this Lease, except that:
  - (i) there shall be no further right to extend after the expiry of the Extension Term unless consented to by the Landlord;
  - (ii) the Minimum Rent shall be such amount as determined by subsection (c) of this section; and
  - (iii) there shall be no leasehold improvement allowance or rent-free period or any other inducement, and the Occupied Premises shall be accepted by the Tenant in "as is" condition at the commencement of the Extension Term without the Landlord being required to perform any work."

The Agreement states that each such extension must be exercised by written notice no later than nine (9) months prior to the expiry of the original Term – in this case SSEA has until July 31<sup>st</sup>, 2022 to exercise said option. The matter was presented to the SSEA Executive on June 13<sup>th</sup> who endorsed staff's plans to exercise the option for a new 5-year lease. A registered letter was sent on July 7<sup>th</sup>, 2022 informing Newmarket Hydro of SSEA's intent to exercise the option.

Both parties must agree on a new rental schedule 3 months prior to the lease expiring or then go to arbitration. While the SSEA Executive did ask how a new agreement might impact the 2023 Budget, staff is confident an acceptable rate can be negotiated. There is significant cost savings in remaining at the current facility. SSEA's 2018 move from Midland to Tay cost about \$30,000. Items to consider when moving include: rental storage, utilities, property taxes, water/wastewater fees, insurance, network setup, telephone system purchase/move, security, cleaning, moving services, accessibility, painting and office configuration.

Exercising the option allows SSEA to focus on more pressing budgetary matters, while providing stability, knowing where SSEA will be located the next 5 years. SSEA has worked with Simcoe County Economic Development staff on this issue, but were unable to find other viable options with commercial vacancies dropping significantly, while price per square foot rising significantly.

# Conclusion

Exercising the option allows SSEA to explore potential partnerships, other locations, working-from-home hybrids, as well as, time to do a proper administrative office needs assessment.

# **Purpose of Staff Report**

The purpose of this report is to provide an update on the key activities and accomplishments of the SSEA Invasive Species Program during Q2 of 2022.

# **Background**

The Invasive Species Program is a core program of the SSEA. The SSEA is working to address public and municipal concerns regarding non-native invasive species establishment within the Severn Sound watershed, and to reduce the ecological, economic and social impacts of invasive species while fostering regional partnerships and community relations.

#### **Updates**

The SSEA was fortunate to receive wage subsidy support through Canada Summer Jobs and the Ontario Federation of Anglers and Hunters; as a result, two youth were hired in Q2 to support the SSEA Invasive Species Program, increasing capacity for project delivery.

# Monitoring, Management & Technical Support

- 2021 Municipal Invasive Species Reports were finalized and distributed to municipal representatives. The consolidated report is available on <a href="SSEA website">SSEA website</a>.
- In 2021, the SSEA detected invasive zebra mussels in Orr Lake, therefore this quarter the SSEA worked with the Township of Springwater to install five artificial substrates in Orr Lake to detect for the presence of adult invasive mussels. A <a href="Public Notice">Public Notice</a> was published.

- The SSEA invasive species team helped the Township of Severn identify Giant Hogweed along the Uhthoff Trail to target management.
- Aquatic invasive species surveys were completed in Sturgeon Bay with help from Georgian Bay Forever for transportation.
- A Phragmites DNA sample was taken and submitted to the Invasive Species Centre for identification through the Ontario DNA Screening Program.
- SSEA participated in, supported and/or facilitated 6 volunteer management events:
  - Wye Marsh, Tay Buckthorn
  - Copeland Forest, Oro-Medonte Garlic Mustard (2)
  - Lafontaine Beach, Tiny Spotted Knapweed
  - o Rotary Champlain Wendat Park, Penetanguishene Phragmites
  - Tiny Marsh, Tiny Phragmites

# **Education & Outreach**

- Responded to a total of 25 new invasive species inquiries, across all eight partner municipalities, providing technical support to municipal staff and the public. Inquiries were related to identification, requests for information and community science related to invasive/non-native species.
- Presented on watershed-wide invasive species management at the Joint Aquatic Science Meeting before an audience of IS practitioners in the Great Lakes region.

# Funding

- Two Invasive Species Technicians (8-week contract staff) began in May 2022 to support the delivery of the Invasive Species Program, supported by a wage subsidy from Canada Summer Jobs and Ontario Federation of Anglers and Hunters.
- Received \$1,000 from the Huronia Community Foundation Smart and Caring Grants for expansion of the Invasive Species Spotters citizen science program

#### **Special Projects**

- Continued to deliver work on the 2021-2022 Farlain Lake Eurasian Water-milfoil (EWM) Management project, including providing technical expertise.
- Continued to deliver work on the 2020-2024 Wye Marsh Invasive Species Management Project, including technical support, and field work assistance.

#### Conclusion

The SSEA Invasive Species Program has successfully fostered relationships with municipalities, partner organizations and associations. Staff continue to research and identify external funding opportunities and support municipal and community-led invasive species projects. Accomplishments are shared through presentations, social media and other communications. Significant activities and tasks, including public and municipal outreach and education, were accomplished in the Q2 of 2022 benefitting the SSEA partner municipalities and community.

#### Purpose of Staff Report

The purpose of this report is to present to the Board progress to date with implementing the Sustainable Severn Sound Program.

#### **Background**

The aim of the Sustainable Severn Sound (SSS) Project is to assist SSEA's municipal partners advance practices and policies within their operations to help implement their Municipal Climate Plans – with the goals of mitigating greenhouse gases and creating sustainable communities.

In 2018, six of SSEA's partner municipalities joined the Federation of Canadian Municipalities-ICLEI Local Governments for Sustainability's *Partners for Climate Protection Program*. Subsequently, in 2022 the Township of Springwater has signed onto the SSS Program.

# **Analysis/Discussion**

Staffing for the SSS Program has been challenging with turnover leading to other SSEA team members trying to assist with deliverables. With the competition in the current job market and inability of SSEA to secure a candidate through the advertising process, a decision was made to contract the service of a consultant in order to assist in meeting the Program's deliverables for its municipal partners. Section 3.1.7 of SSEA's Joint Municipal Board Service Agreement allows the Executive Director to "...retain the services of consultants, contractors and experts in order to meet the objectives of the Business Plan and the Strategic Plan." As well, Tay's Procurement Policy (Schedule A) allows for the sole-source acquisition of Professional and Special services if one of those services is temporary heterally allows for the Strategic Plan.

# **Purpose of Staff Report**

The purpose of this report is to provide an update on the spring 2022 Community Tree Planting and Tree Seedling Distribution programs including program results.

#### **Background**

The Severn Sound Remedial Action Plan/SSEA has been involved in facilitating, coordinating and supporting tree plants since the early 1990s, to increase forest cover and biological diversity, and improve wildlife habitat and stream water quality. The SSEA helps with project planning, obtaining native tree and shrub seedlings, and coordinating a variety of groups and volunteers, including local schools and community organizations. More than 242,000 seedlings have been planted through this Program to date.

To supplement the Community Tree Planting Program, the SSEA started the Tree Seedling Distribution Program in 2007. This over-the-counter 'plant your own' tree sales program provides property owners with reasonably-priced, native seedlings for spring planting - increasing local tree cover. Nearly 135,600 seedlings have been purchased and planted to date by participants.

In addition to water quality and habitat benefits of planting trees, there is a value in carbon capture: the Tree Canada Foundation reports that the 'average' Canadian tree's <u>annual</u> carbon storage is 2.5 kg in an urban environment, and 2.8 kg in a rural environment, and the <u>lifetime</u> carbon sequestration per tree is 200 kg and 225 kg in urban and rural environments, respectively<sup>1</sup>.

#### **Analysis/Discussion**

In spring 2022, the Tree Seedling Distribution Program was implemented using the curbside-style pick-up model, pre-arranged pick-up times for participants, and COVID-19 safety protocols that were developed and used effectively in spring 2021. Member municipalities were very helpful in promoting the initiative, as well as, providing logistical support with seedling transportation and distribution. This year's Program was very successful, with eight native tree species and one shrub species distributed (White Pine, White Spruce, White Cedar, Balsam Fir, Tamarack, Sugar Maple, Black Walnut, Shagbark Hickory, and Nannyberry). Response to the initiative was good, and SSEA sold out of available seedlings before the order deadline in January. In total, 228 participants from all municipalities purchased and planted 8,740 native seedlings.

SSEA implemented two community tree planting events in late April and early May at a property in Oro-Medonte abutting the Sturgeon River; Scouts Canada, a long-time partner of SSEA, planted 800 seedlings on April 30<sup>th</sup>, and SSEA staff, Board, and volunteers planted an additional 640 seedlings at the site on May 13<sup>th</sup>. In addition, a volunteer planted 15 seedlings of two species at the Township of Tiny arboretum on May 20<sup>th</sup>.

### **Expected Impact on SSEA budget/workload**

The SSEA sets seedling prices so that the Tree Seedling Distribution Program is self-funded. In addition to funds from seedling sales, the SSEA was approved for a \$0.25 per tree subsidy up to \$2,100 from Forests Ontario for the 2022 Program.

For Community Tree Planting projects, 100% of the cost of seedlings planted by volunteers, amounting to \$1,705 for spring 2022, is reimbursed through a County of Simcoe Forestry grant. The County funds are available through a multi-partner, four-year (2019-2022) MOU between the County and SSEA, Dufferin Simcoe Land Stewardship Network, NVCA and LSRCA. The SSEA's staff costs for organizing and implementing Community Tree Planting are covered through core funding.

#### Conclusion/Recommendations

The SSEA is in planning stages for our spring 2023 programs. Staff will be conducting site visits to prospective properties in summer and fall, and ordering seedlings for both programs in fall 2022.

#### **Purpose of Staff Report**

The purpose of this report is to provide a summary of the Q2 2022 Projects for Pollinators Initiative progress and achievements to the SSEA Board of Directors.

#### **Background**

Through foraging behaviours that move pollen around, pollinators like butterflies, bees, bats and birds play an essential role in terrestrial ecosystems, as well as, in food production. Pollinator populations are declining and one of the biggest reasons is habitat loss from land clearing, development and spread of invasive species. Creating, enhancing and protecting habitat for native pollinator species can help reduce some of the threats in the Severn Sound area.

Habitats can be created, enhanced and protected through initiatives like invasive species management, a new SSEA initiative called Projects for Pollinators (P4P and the Bee City Program which the Town of Midland, and Townships of Tiny, Severn and Georgian Bay are members of. Certain management practices, such as reduced mowing, also contribute to climate mitigation actions identified in municipal climate action plans.

#### **Analysis/Discussion**

The SSEA was successful in receiving funding from TD Friends of the Environment Foundation (TD FEF) for the P4P initiative. The funding covers the cost of plants for pollinator gardens in Bee City municipalities, materials for pollinator kits, and support for staff to create social media posts, pollinator kits and educational material, and coordinate volunteers for planting events.

#### Habitat Creation & Enhancement

Related to the P4P initiative and as part of the second phase of the Depave Paradise Program at Honey Harbour Park, a pollinator garden was planted on the property. Planting took place on June 21<sup>st</sup>, 2022 with help from grade 4-8 students at Honey Harbour Public School and

volunteers from the Baxter Ward Lion's Club. Over 30 different native species of flowers, grasses, shrubs and trees were planted, for a total of 317 plants. The purpose was to enhance native pollinator habitat and increase biodiversity at the site. Plants were purchased from local nursery, Hidden Habitat, using funding from the TD FEF grant. Hidden Habitat also provided garden planning and site preparation services.

SSEA plans to plant pollinator-attracting native plants in partnership with Bee City members and coinciding with invasive species management efforts at municipal parks. These planting days will also serve as an opportunity for volunteers to get hands-on experience protecting and establishing local pollinator habitats, removing invasive species and planting native pollinator species. Pollinator kits will be handed out at these events.

# Education and Outreach

June 20-26, 2022 was Pollinator Awareness week, and provided an excellent opportunity for education and outreach. Social media posts went up each day with information on topics related to pollinators and plants that attract them. Posts included information about local pollinators and plant species and relationships, considerations in creating a pollinator garden, climate change impacts on pollinators, actions to avoid to protect native pollinators and plants, as well as, a summary of activities undertaken by the SSEA to improve and maintain pollinator habitats.

A section on the SSEA website was created called <u>Pollinator Habitat</u>, which gives general information on pollinators, details SSEA involvement supporting Bee City municipalities, and provides information on the P4P Initiative and Depave Paradise Project in Honey Harbour.

#### Pollinator Kits

A Pollinator Helper Handbook and Pollinator Plant Guidebook are being developed. These will be in the Pollinator Kits which also include native species seed mix, and reusable lawn flags for marking no-mow zones. The Pollinator Helper Handbook includes information on garden site preparation, as well as, on how to choose native plants for pollinator gardens. The Pollinator Plant Guidebook will describe plant species native to the Severn Sound area, with details on soil, light, and moisture requirements, historical facts, and physical features. The SSEA plans to hand out Pollinator Kits at events to encourage members of the public to create and enhance pollinator habitats. Seed packets have been given out at numerous SSEA events so far this summer.

#### **Financial Implications**

The P4P Initiative is funded by TD FEF (\$8,000), with in-kind from SSEA (about \$6,180).

#### **Conclusion/Recommendations**

SSEA is undertaking projects and activities to create, enhance and protect pollinator habitat. This work contributes directly multiple goals and objectives of the SSEA and partner Municipalities. Benefits reach beyond creating and protecting pollinator habitat to contributing to municipal climate action goals.

#### **Purpose of Staff Report**

The purpose of this report is to provide a summary of the Q2 2022 Depave Paradise Project progress and achievements to the SSEA Board of Directors.

#### **Background**

On July 26<sup>th</sup>, 2021, the Board supported the staff recommendation for SSEA to participate as a delivery agent in the Depave Paradise Program, a project of Green Communities Canada. Hardened surfaces have negative impacts on local waterways due to the disruption of the natural water cycle and the movement of contaminants through stormwater runoff. As summarized in SSEA's SSS Local Climate Change Action Plan, the projected rise in global temperatures is expected to result in intensification of the water cycle, causing more severe droughts, increased total precipitation, and increasingly intense storm events. By participating in the Depave Paradise Program, SSEA was able to encourage the use of green infrastructure or Low Impact Development (LID) features to help to minimize the impacts of hardened surfaces. By becoming a delivery agent in the Depave Paradise Program, SSEA was able to offer an engaging way to involve the local community and educate residents on the benefits of green infrastructure, as well as, pollinator habitats while improving the hydrological and ecological function of public lands.

#### Analysis/Discussion

SSEA staff worked with the Township of Georgian Bay to plan and implement our first Depave project. A site was identified at Honey Harbour Park, which the Township had plans to revitalize, including the removal of an old skating rink and replacing it with a smaller rink and covered pavilion. On May 1<sup>st</sup>, 2022 SSEA and Township staff along with community volunteers removed roughly 100 m² of the rink by hand. The removal event was attended by 14 volunteers, who contributed 35 hours to the project. The planting phase of the project occurred on June 21<sup>st</sup> with the help of 24 volunteers, including 16 grade 4-8 students from Honey Harbour Public School

and 5 volunteers from the Baxter Ward Lion's Club who collectively contributed 72 hours to the project. Volunteers planted 33 species of native trees, shrubs, grasses and wildflowers, for a total of 317 plants. Species were selected to provide food and habitat for pollinators.

Since plans at the Park have evolved to include six pickleball courts, replanting did not occur in the same location as the depaving. However, the equivalent of ~100m² in pollinator gardens were established around an existing pond, and as such will act as an additional buffer to prevent stormwater runoff from ultimately entering Georgian Bay. SSEA continues recommending the Township install a permeable border around the courts and pavilion to capture runoff.

Aside from the event days, educational engagement included:

- Social media posts to Facebook, Instagram and Twitter with 21, 27 and 20 posts, and 163, 433 and 212 instances of engagement (likes, shares, comments, etc.), respectively
- Information shared through SSEA staff reports and board meeting videos, and Township of Georgian Bay council meetings and social media posts
- Total instances of engagement approx. 1000 people

Additionally, a draft educational sign was created and a section on the SSEA website has been dedicated to Pollinator Habitat, and includes information about the Depave Project.

A big thank you to Mayor Koetsier, Councillor and SSEA Board Vice Chair Wianko, Councillor Jarvis and CAO Julie Bouthillette from the Township of Georgian Bay, and to Deputy Mayor and SSEA Board member Dubeau from the Town of Penetanguishene for helping with the project.

# **Financial Implications**

SSEA was granted \$15,000 to support the implementation of the Honey Harbour Depave Project for 2022. The final \$5,000 will be received following the final report.

There are still outstanding costs to be paid and it is anticipated that \$8,430 of the GCC funds will go towards SSEA staff time. SSEA contributed approximately \$16,700 of in-kind staff time, and \$1,040 in-kind for supplies and tools. The funds received from GCC aim to cover other project costs including plants, event day materials, garden plan and site preparation, educational signage, photography and video production. A portion of the TD FEF grant went towards the purchase of plant materials for the Honey Harbour garden. As part of their in-kind contribution, the Township of Georgian Bay covered the cost of cutting and removing the asphalt, along with port-o-potty rental. The total amount of in-kind from the Township, is approximately \$5,185.

#### **Conclusion/Recommendations**

The Depave Project at Honey Harbour Park has resulted in the successful installation of a pollinator garden, as well as, provided the opportunity for education and outreach on stormwater, low impact development, biodiversity and pollinator habitat.

# **Purpose of Staff Report**

To outline key events hosted and attended by SSEA in Q2, and upcoming events in Q3 of 2022.

#### **Background**

Engaging with community and partner organizations is one of SSEA's core services. Facilitating and participating in community events or virtual webinars allows SSEA to:

- Engage and educate community members, and promote SSEA programs and services;
- Encourage stakeholders and community to follow best management practices; and
- Increase capacity through volunteers to deliver services and special project work.

#### **Analysis/Discussion**
